## Lexington Friends Meeting Meetinghouse Use Policy and Application

Lexington Friends want our Meetinghouse to extend and promote Quaker values and to serve our local community. We wish to make our Meetinghouse available to those who would like to use it, as our schedule allows. Use of the meetinghouse must conform to the conditional use for our property granted to us by the Board of Adjustment of the Lexington Fayette Urban County Government. We establish the following policies and procedures for the use of the meetinghouse.

Requests to use the Meetinghouse will be processed through the Property Management Committee. Inquiries and requests can be made to the Building Manager (see contact info below). The Property Management Committee can approve many of the requests for building use. Some requests, however, may need to be approved by our monthly Business Meeting, which usually occurs the first Sunday of the month. To meet this schedule it may several weeks to consider some applications.

**Rental Fees.** Rental fees cover the meeting's expenses to maintain a clean, safe, well-functioning facility. We strive to keep our fees as low as possible and structure our fees to cover the costs of utilities, cleaning, maintenance, and normal wear and tear. We may adjust the rental rates periodically. We urge users of the facility to help keep costs down by **being respectful of the building and by paying attention to energy and water use.** 

Cooperating with our neighborhood Lexington Friends Meetinghouse is located in a residential neighborhood. We are the only building on Price Avenue that is not a residence. Our property is zoned residential with a special conditional use allowing us to operate a church on the property. Our neighbors have expressed great concern about noise, additional traffic on Price Avenue, and parking on the street generated by our use of the building. When coming from Broadway we ask that people take Delcamp Drive rather than Sixth Street in order to minimize the traffic on our block. There is a left turn signal on the light at Broadway and Delcamp Drive, making it an easy turn. In addition, we ask all who visit our building to park in our parking lot rather than on the street. Many of our neighbors rely on on-street parking.

**Making application** To use the facility, please fill out an application. You will be asked to read and agree to our policies for use of the building including use of the kitchen if applicable. In most cases, a key deposit of \$25.00 and a security deposit (\$75) will be required. Submit this application along with a check, made out to Lexington Friends Meeting, for the deposit to:

## **Meetinghouse Use Policies**

- 1. Watch and protect children. Children and youth using the Meetinghouse or on the Meetinghouse grounds must be accompanied by adult sponsors at all times.
- 2. Limit use of natural resources. Avoid excessive use of heat, air conditioning, water, and lighting. Windows should not be opened.
- 3. Leave the Meetinghouse in the condition that it was in when entered (or better!). Clean up, and return furniture to original places. Report any damage or any needed repairs to the Building Manager (see contact info above). Users are responsible for paying any damage not covered by the security deposit.
- 4. The use of tobacco, illegal drugs, or alcohol, and the possession of weapons are prohibited anywhere on the Meetinghouse grounds (inside and out).
- 5. Whenever the kitchen is used, the **Kitchen Procedures** (see below) shall be followed and kitchen rental fee paid.

Lexington Friends Meeting will allow use of the facility only to those who can affirm that they will follow these procedures. Users who fail to follow these procedures will be asked to leave.

We ask that persons using the facility respect Quaker testimonies, including equality, simplicity, nonviolence, and seeking the sacred within each person. Groups and individuals using the Meetinghouse may not discriminate against anyone for reasons including but not limited to race, sexual orientation, age, gender, gender identification, religious beliefs, national origin, ethnicity, or physical ability.
